Oklahoma Community Sentencing Act in brief.

The Community Sentencing Program is monitored by the Planning Council which ensures the safety, quality and success of the program.

Eligible offenders have been convicted of a felony and have an LSI assessment or another authorized assessment recommending Community Sentencing.

The District Attorney or ADA ensures offenders meet criteria for eligibility. The Judge uses the recommendations by the DA, Defense Attorney, and LSI to impose the sentence, which may or may not be Community Sentencing.

Participants are required to participate
fully in their treatment plan and probation
requirements. Participants are also
required to pay a monthly Supervision Fee
& Administrative Fee.

Incentives are used to encourage success in the program and reward achievements.

The court may impose sanctions, modify/
revoke/accelerate the sentence when participants fail to comply with program rules.

Program Content:

Life Skills Development-

learning and applying conflict resolution techniques, budgeting skills, scheduling, and social skills.

Vocational Development-

learning job skills, resume building, employment goals, & facilitating enrollment continuing education or technical training programs.

Cognitive Behavior

<u>Training</u>—developing problem solving skills, coping strategies, & emotional regulation.

Individual & Group

Therapy— addresses trauma, relapse prevention, mental illness & allows for deeper insight and accountability.

Program Structure:

Each participant will is assessed for mental health, substance abuse, educational, vocational and social/family area's of need, through the Level of Service Inventory. A treatment plan is developed from the LSI (LSI-R) identifying the programs the participant will participate in. Treatment is provided based on the assessment & results.

Supervised Probation is a

component that teaches accountability and reinforces maintaining sobriety. Participants are subject to random UA's and home visits. Participants meet with their Probation Officer at least monthly to monitor their progress in employment, program progress and fidelity.
